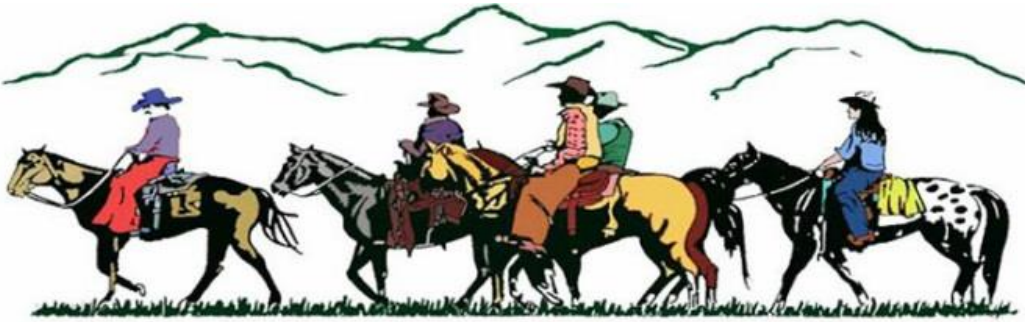

Four nights, **September 28-October 2, 2017.**

Signups have started tonight. 40 corrals will be available at \$80 each. Payment was required to be turned in at this General Meeting to reserve spots. 43 corrals were sold at the meeting. So camp is

now full. Members approved 43 instead of 40 corrals sold, and if there are any cancellations, we are not replacing reservation until under 40 corrals. Any mail-in reservations will go on a waiting list. Due to corrals sold, day riders closed after two sign-ups.

If members come for the day with no horse, then there is no charge. But if members are coming for Saturday dinner, they must fill out a reservation for the dinner count.

There will be a potluck dinner on Saturday night with the club furnishing the tri-tip for meat. Members will bring side dishes, salads or desserts.

Standing Rules

Proposed revisions were sent out via email with the newsletter/minutes on August 8 and asked for discussion/changes to be submitted by noon on Tuesday, August 15.

The following is the only addition to the Standing Rules was received via email. It was proposed that we add the following to our standing rules:

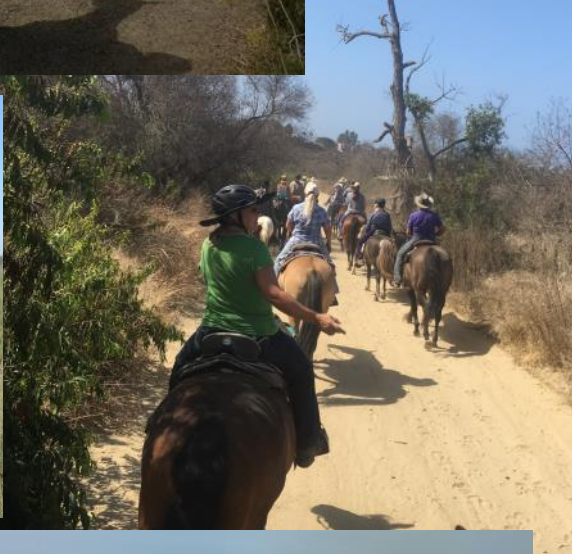
